Order:-

The visiting devotees of Lord Venkateswara Swamy have been increased day by day and the workload has been increased gradually. As a result, the deputation to the regular employees are also increased. Due to age and health factors, absentees to the Parakamani has been increased. As a result, the quantity of work load was piled up at Parakamani, Tirumala/Tirupati.

The TTD Employees Association joint action committee, Tirupati, represented that "Scope of Work" has been increased drastically to the Attenders and hence requested the management that Parakamani and deputation duties may be cancelled.

Accordingly, the TTD Board has resolved vide 1st read above, that the Executive Officer be authorized to work out suitable alternative mechanism in consultation with interested banks to carry out Parakamani work. But, no independent bank has shown interest to deploy the manpower at Parakamani, except the union Bank of India & State Bank of India are jointly supplying man power to Currency Parakamani, Tirumala through ABREPOSE services limited.

The Executive Officer, TTD has constituted a committee vide 2nd read above, with the Senior officers of TTD and after verifying and analyzing the conditions at Parakamani both at Tirumala and Tirupati, the committee submitted recommendations for **Re-Engineering the working process of Parakamani.**

On the recommendation of the committee, the following proposals were placed before the TTD Board for Re-Engineering the work process at Parakamani.

- To Engage the workers from ABREPOSE (Andhra Bank Retired Employees Projects of Self Engagement) 35 +35 =70 no's Unskilled + Highly Skilled - 4 nos. (for supervisory work) of workers for two batches at Currency Parakamani, Tirumala and 65 nos. of workers per day at Coins Parakamani, Tirupati for a period of 03 years on payment of wages under Highly skilled category for supervising staff and unskilled category for workers.
- 2. To post 2 Sr.Asst's and 2 Jr.Asst/Asst's for Coins Parakamani, Tirupati and 2 Sr.Asst's and 4 Jr.Asst's for Currency Parakamani, TTD, Tirumala on permanent basis duly, dispensing the daily deputation duties to the regular staff. The staff posted on permanent basis should be transferred on completion of one year period.
- 3. To sanction an amount of Rs. 1.1 Cores for three months (JANUARY-2024 to MARCH-2024) for the financial year 2023-2024 and an amount of Rs. 4.5 crores for the financial year 2024-2025 for payment of wages to the workers engaged through the ABREPOSE.
- 4. The Executive Officer, TTD is permitted to review the requirement of man power and wages from time to time and permit to take up renewals on yearly basis only after satisfactory performance of workers and to engage additional man power, if required, to clear the pendency of work.

"The TTD Board approved the above proposals for a period of ONE YEAR and Board authorizes the Executive Officer, TTD to extend for two more years depending on the performance" vide 4th read above.

Hence, permission is here by accorded to the Dy.Exe.Officer (Parakamani), Sri T.T., Tirumala to engage the workers from ABREPOSE (Andhra Bank Retired Employees Projects of Self Engagement) <u>70 no's</u> <u>Unskilled + Highly Skilled - 4no's (for supervisory work)</u> of workers for two batches at Currency Parakamani, Tirumala and **65 nos. of workers per day at Coins Parakamani, Tirupati** for a period of 01 year on payment of wages under Highly skilled category for supervising staff and unskilled category for workers duly framing the terms and conditions keeping in view of security aspects to extract the work.

The Dy.Exe.Officer, Parakamani is permitted to make agreement with ABREPOSE manager for deploying the workers to Parakamani by specifying the guidelines.

The Manager, ABREPOSE is directed to <u>deploy the man power from</u> **1st February-2024 to Parakamani both Tirumala and Tirupati** on fulfilling the norms, terms and conditions, besides verification of Antecedents by TTD Vigilance department.

The Dy.Exe.Officer (HR), TTD is permitted to **post 2 Sr.Asst's and 2 Jr.Asst/Asst's for Coins Parakamani, Tirupati and 2 Sr.Asst's and 4 Jr.Asst's for Currency Parakamani, TTD, Tirumala in addition to the existing staff on permanent basis** duly dispensing the daily deputation duties to the regular staff and the staff posted on permanent basis should be transferred on completion of one year period.

The FA&CAO is requested to release the budget for an amount of Rs. 1.1 Cores for three months for the financial year 2023-2024 and an amount of Rs. 4.5 crores for the financial year 2024-2025 for payment of wages to the workers engaged through the ABREPOSE.

The CV&SO, TTD, Tirupati is requested to instruct the concerned to take necessary further action in the matter.

The AEO (I & II), Currency Parakamani, TTD, Tirumala and the AEO Coins parakamani, TTD, Tirupati is directed to take further course of action accordingly.
