The name of the APP is "FUPI MOBI".

Step No. 1	:	To Download the APP, you have to go to "PLAY STORE" and type "FUPI" in the search.
Step No. 2	:	Then click on "FUPI Mobi Mobile". Then click on "Install" The App will be installed.
Step No. 3	:	It will ask for Company ID. Please type the Company ID: 1131 and click "Submit"
Step No. 4	:	Please click on "While using the APP"
Step No. 5	:	Again, it will ask for Institution ID. Please type 1131 and submit
Step No. 5	:	Please Type Branch ID: 1. Please type the Customer ID and PIN received through SMS in your messages. Then Click on "ACCOUNT VERIFICATION".
Step No. 6	:	Then it will ask for OTP. Please enter the OTP received in your mobile and click on "OK". The site will open.
Step No. 7	:	You will see the following 4 icons: 1. Account 2. Statement 3. My dues 4. My liabilities

Step No. 8	:	<p>Please click on "ACCOUNT". If you are a shareholder, you will get the total amount of shares invested in ABREPOSE. (Cr.) Represents the Credit Balance of shares with ABREPOSE.</p> <p>Note:</p> <p><u>IF YOU ARE A BORROWER:</u></p> <ol style="list-style-type: none"> 1. you may get the account statement by clicking on "STATEMENT" 2. You may know the dues in the loan account by clicking "Dues" 3. You may know the Outstanding balance in the loan account by clicking "MY LIABILITIES"

5. Forgot PIN: You may get a new PIN, if you forgot the PIN Number.
6. About (About the Software company who initiated the APP)
7. Terms of Use: terms and conditions of usage
8. Privacy Policy

To LOGOUT from the APP, CLICK on the ICON at the right-hand side TOP Corner.
